
Federal CSRM Funding in Florida:

Work plan: ?+

Supplemental: ?+

FCCE: Yes, but how much?

Clues to psychic predictions:



- Damages are fairly similar to those under Matthew although more projects, and more expensive projects requested assistance.
- There will also be savings on those projects already mobilized.
- Under current guidance FCCE would be reduced which means Supplemental (cost shared) would be increased.

Other considerations: Could we actually get authorized but not constructed projects funded in a supplemental bill?
