## A Message from the Incoming Chair



Richard Bouchard, St. Lucie County FSBPA 2015 Chair

A look back at 2014 again illustrates the importance of FSBPA to Florida's beaches and the state's beach management Coming off an program. exceptional 2013 devoted to damage storm recovery, expectations for this year were somewhat unclear. We knew that there would not be the massive funding and leadership contribution of the U.S. Army Corps of Engineers, but what we didn't know was if the \$37 million in state cost-sharing in

2013 was the starting point for this year or not. The 2014/15 budget recommendation of DEP and the Governor of \$25 million suggested it was not. In turn, FSBPA's strategy for 2014 was to significantly increase the level of state funding.

The outcome was far beyond our Board of Directors expectations thanks to Legislature, and the Association's efforts including the involvement of you, our members, and our staff and consultants. The current fiscal year \$47.3 million appropriation is for 25 separate beach and inlet management projects as well as for post-construction monitoring for numerous projects.

Where do we go from here and how do we get there, knowing that this year's exceptional level of program funding is nothing more than a one-

time allocation? For the past few months FSBPA has tried to chart a course forward, knowing time is short, yet not knowing the details regarding Amendment 1 and how, and if, it will reaffirm dedicated beach funding from documentary stamp tax revenues. We must work together to influence those answers. No one can argue that the existing 1998 documentary stamp tax commitment of \$30 million for beach repair is inadequate, leaving far too many needed beach projects unfunded. What we don't know for certain is whether the Legislature will address this as part of their implementation of Amendment 1. You can be certain FSBPA will do its best to encourage a positive answer. It is so very important that you individually, collectively as local communities and governments, and organizations and interests be informed and involved. We all know how important beaches are to tourism, storm damage reduction, economic prosperity, environmental resource protection, and our quality of life, but unless we communicate and reinforce that message effectively and advance it from the local to the state level, beaches could be left behind as the discussion going forward centers on water quality.

This is our focus. Beaches and their benefits are simply too important to have winners and losers. As your Chair for 2015, I urge each of you to lend meaningful support to the effort. Make sure your local elected officials and your legislative delegation members know how important it is to ensure beaches benefit from continued and increased dedicated documentary stamp tax revenues. Please continue to be the advocate you joined FSBPA to become and ensure the future health of Florida's beaches.

# Jacksonville District to Become Regional Center of Expertise (RCX) for Regional Sediment Management (RSM)

Recently the South Atlantic Division (SAD) Regional Management Board unanimously approved Jacksonville District to become the Regional Sediment Management (RSM) Regional Center of Expertise (RCX) for SAD.



RSM is a systems-based approach that integrates the management of littoral, estuarine, and riverine sediments to achieve balanced and sustainable solutions to sediment-related needs in a region. The RCX has a vision of bridging USACE business lines through implementation of RSM principles.

The role of the RCX will be to provide experience-based guidance on the practical application of RSM principles to USACE mission areas of Navigation, Coastal Storm Damage Reduction, Ecosystem Restoration and Flood Damage Reduction. The RCX will be a technical resource for districts on the full array of RSM tasks including assistance with annual RSM proposals, RSM study execution, resource agency coordination, and implementation of RSM strategies. The RCX will focus on helping districts integrate RSM concepts into new and existing dredging projects and on better quantifying the benefits of RSM efforts.

The selection as the RCX is largely in part to the RSM efforts and accomplishments of the Jacksonville District to date. In North Florida alone, over recent project history, there has been a "savings" or added value of over \$90 million through the implementation of RSM principles to Navigation and Hurricane and Storm Damage Reduction (HSDR) projects within the region. In 2013, RSM principles were implemented to place sand from emergency Navigation O&M projects on the beach at HSDR projects to achieve roughly \$27 million of increased value to the Nation. These savings were a result of a reduced need for sand from the offshore sources permitted for use by these projects due to the beneficial use of sand from the navigation dredging.

With coordination and cooperation being the most important part of RSM, these successes would not have been possible without the efforts of project sponsors, resource agencies, and stakeholders throughout the state of Florida.

The Jacksonville District is looking forward to expanding the implementation of RSM principles in its new role as the RCX. The current and future initiatives of the RCX include identifying subject matter experts across the South Atlantic region, developing a website, developing standard operating procedures for quantifying RSM benefits, developing an RSM communication plan, and implementation of RSM strategies into project design and construction.




Figure 1. Sediment sources and needs, St. Augustine Inlet vicinity, FL.

An example of past success by the Jacksonville District with regional sediment management is in the vicinity of St. Augustine Inlet. An evaluation at St. Augustine Inlet identified sediment needs and sources and led to consideration of how sediment can best be managed among all the projects. Review of RSM strategies and collaboration with stakeholders in the region led to the use of high shoaling areas within the inlet as sediment sources for the erosional beach to the south of the inlet in a recent dredging project.

## 2014 Update to the Strategic Beach Management Plan Available for Public Comment




The Department of Environmental Protection held public meetings on the 2014 update to the Strategic Beach Management Plan (SBMP 2014) on December 9, 10 and 11<sup>th</sup>. These meetings provided an overview of the updates to the 7 different regions as well as the introduction of the SBMP.

The Strategic Beach Management Plan (SBMP) documents the specific strategies for constructive actions at critically eroded beaches and inlets. Projects must have a clearly identifiable beach management benefit consistent with the SBMP to be eligible for state funding assistance. Resources and opportunities to achieve the strategic goals of the program are discussed in the context of a subregion defined by the boundaries of distinct coastal littoral processes. The SBMP also provides a summary of previous actions taken to address beach erosion within each subregion.

September is an excellent month to fish in the Florida Keys. Inshore, big bonefish and permit are cruising the shallows, and our backcountry waters are loaded with redfish and resident tarpon. Flat-calm conditions make September ideal for site fishing for tailers and wakers using both fly and spinning gear, with the best bites generally occurring early in the morning or later in the day.

On the reef, September offers consistent rod-bending action for a variety of hard-fighting and great tasting species. Book a half-day trip with one of our seasoned pros and bring home a cooler full of delicious mangrove, mutton, and yellowtail snapper filets. You may even land a big black grouper!

Offshore, the blackfin tuna bite is red hot, and it's not too late to catch a trophy slammer mahi mahi (dolphin, as we like to call them). Speaking of offshore fishing, I can't mention the month of September without talking about daytime swordfishing.

The swordfish bite has been outstanding with fish over 200 -pounds common this time of year. Just a few weeks ago our very own Captain George Campbell of Snapshot Charters caught a 405-pounder! No matter what type of fishing you want to do, our deep-sea and backcountry guides will put you on the fish. Take a stroll down to the marina and see what they caught today.
