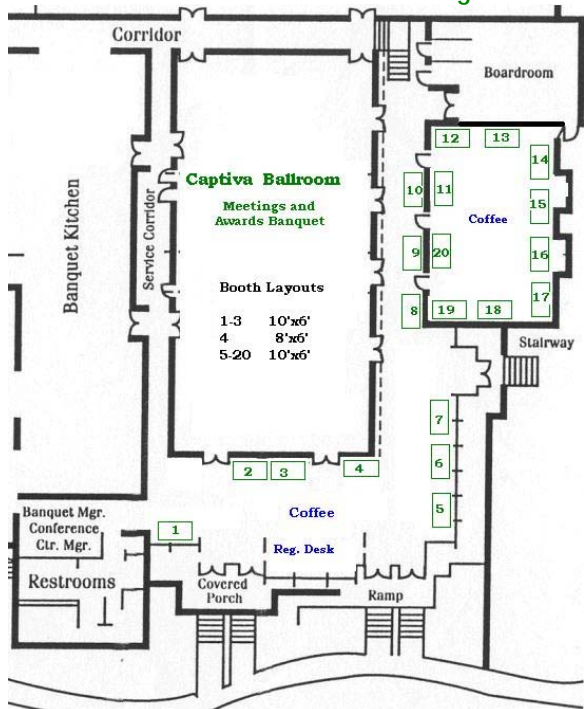


EXHIBIT FLOOR PLAN

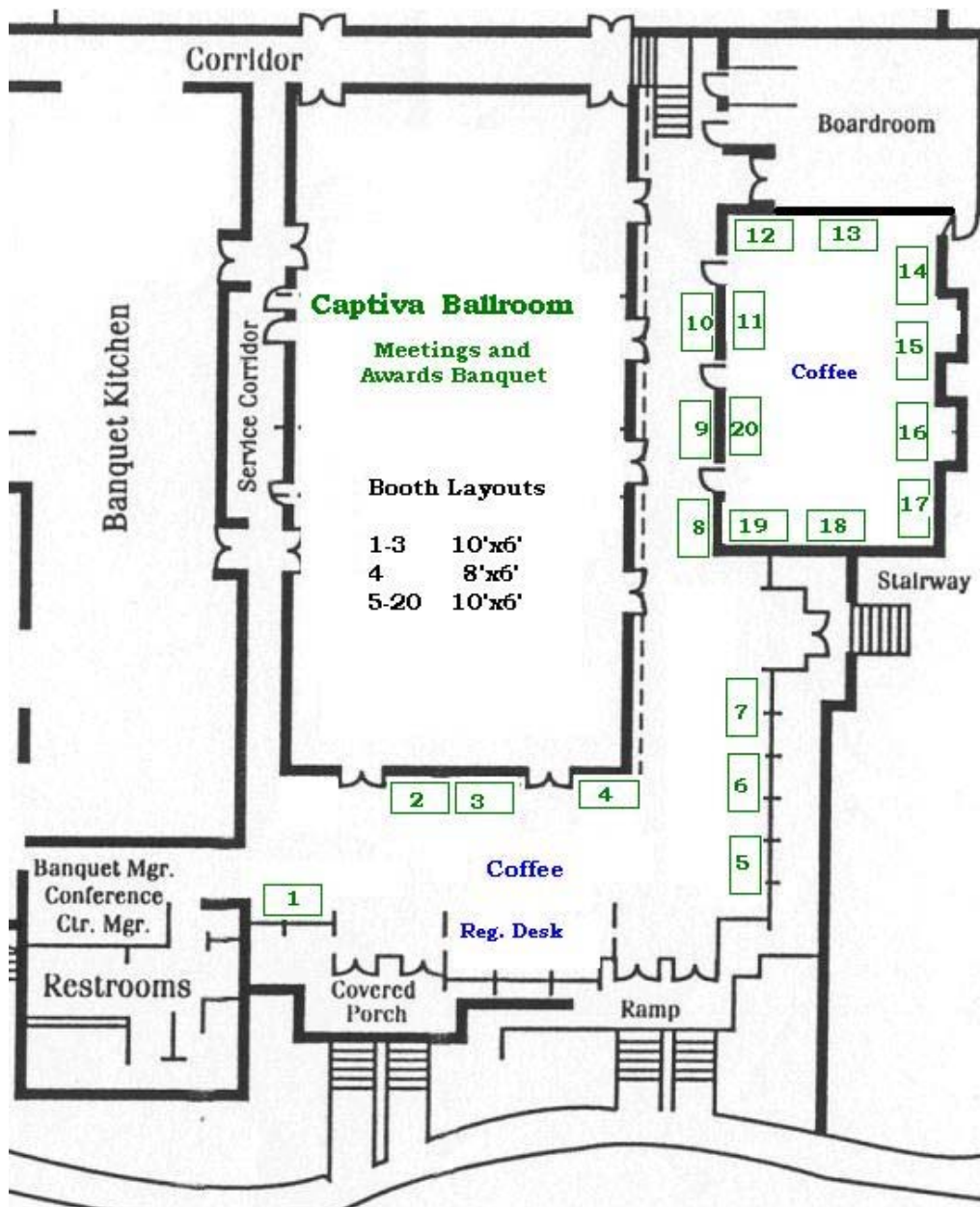
