Statement of Project Goals DEP Parks Service 2004

#1 Restoration of the State Park Beach to meet recreational needs and protection of State Park facilities and infrastructure. Areas of primary consideration for beach fill include the section of shoreline along the area which includes parking and park facilities.

Statement of Project Goals


#2 Protection of natural resources, including north and south shorebird nesting areas, sea turtle habitat, and submerged aquatic vegetation.

#3 Minimization of the amount of sediment entering Hurricane Pass.






Phase I: 6 years Post Construction






Shoreline Change (2001 to 2010)









Honeymoon Island Phase II Goals

 Maintain same goals as Phase I extending the erosion control project north to establish a beach along the park shoreline from DEP Monuments R-9 to R-8 that may be sustainable and managed with future sand placement from maintenance the of the navigation channel at Hurricane Pass or other suitable sources.

Honeymoon Island Phase II Project

- 160,000 cy of sand between R-7 to R-10
- 3 T-groins
- Protect facilities retreat
- Transition N & S
- Inlet sand budget
- Sustainability
- Reasonable fill cycle










